- 2. AN ORDINANCE TO CLOSE A PORTION OF THE EAST-WEST ALLEY LOCATED IN THE 700 BLOCK OF MULBERRY STREET BETWEEN LINDEN AND MULBERRY STREETS (up for the 2nd reading)
- 3. A RESOLUTION APPROVING AN AGREEMENT WITH TYLER TECHNOLOGIES TO PROVIDE PROFESSIONAL SERVICES AND SOFTWARE FOR THE CITY

- A RESOLUTION AUTHORIZING A CONTRACT WITH AUSTIN CONSTRUCTION, INC., FOR WORK REGARDING THE BARRAQUE PARK PAVILION PROJECT 4.
